## MAN & WOMAN OF THE YEAR

The Tucson Metropolitan Chamber of Commerce assumed the Man & Woman of the Year Program from the Tucson Advertising Club in 1983, following a tradition established in 1952. The award program honors a man and a woman who have distinguished themselves for active support of community projects at personal sacrifice, for aiding those persons less fortunate, and for living in a manner which inspires affection, respect and admiration.

### ELIGIBILITY/NOMINATIONS

Any man or woman who has not been honored as a Man or Woman of the Year or Founders Award recipient is eligible.

Nominations must be made on the appropriate nomination form, available from the Tucson Metropolitan Chamber of Commerce, and returned by the nomination deadline.

A resume, providing pertinent information about the individual, and his/her club and organization affiliations, committee service, awards received, and volunteer work **must be submitted with the nomination form**. Even though past accomplishments and involvements should be included, emphasis on the award year is critical. **NOMINATIONS WILL NOT BE ACCEPTED UNLESS A RESUME IS SUBMITTED.**

Letters of support, recommendations and similar materials are accepted, but are not mandatory.

### SELECTION

The Man & Woman of the Year will be selected by a broad-based community committee, appointed by the Chairman of the Board of the Tucson Metropolitan Chamber of Commerce.

The Selection Committee will review the nomination forms and supporting materials for each nominee. The Man & Woman of the Year will have distinguished themselves for actively supporting community projects at personal sacrifice, having aided those persons less fortunate, and living in a manner which inspires affection, respect and admiration.

The Selection Committee retains the right of moving any nominee into the Founders Award category.

### ANNOUNCEMENT

The Man & Woman of the Year will be apprised of receipt of the award on December 31 of the award year, with the public announcement on January 1.

The Man & Woman of the Year awards will be presented during a formal ceremony to be held at the Westin La Paloma.

## **FOUNDERS AWARD**

**The Founders Award was established by the Chamber in 1985 to augment the Man and Woman of the Year Award. This separate and distinct award cites individuals who have demonstrated significant long-term community involvement and accomplishments and who have helped shape the community in a quality, positive manner.**

### **ELIGIBILITY/NOMINATIONS**

Any man or woman who has not been honored as a Man or Woman of the Year or Founders Award recipient is eligible.

Nominations will be accepted from any group or individual; however, groups must identify a contact name. **NOMINATIONS WILL NOT BE ACCEPTED UNLESS A RESUME IS SUBMITTED.**

Nominees for the Founders Award will have demonstrated significant long-term community involvement and accomplishments, the majority of which occurred within the past 10 years. (For example, the Founders Award nominees considered for the 2009 award year should have made the majority of their significant civic contributions prior to 2009, even though they may currently continue to be involved in activities and organizations.)

### **SELECTION**

The Founders Award recipient will be selected by a broad-based community committee, appointed by the Chairman of the Board of the Tucson Metropolitan Chamber of Commerce.

The Selection Committee will review the nomination forms and supporting materials for each nominee. The Committee will base its decision on the demonstration of long-term involvement, dedication, and commitment to the community in past years. The Founders Award will be presented to an individual who has helped shape the community in a positive, quality fashion.

The Selection Committee retains the right of moving any nominee into the Man or Woman of the Year category.

### **PRESENTATION**

Recipient of the Founders Award will be notified on December 31 of the award year, with the public announcement on January 1.

The Founders Award will be presented along with the Man and Woman of the Year Awards during a formal ceremony to be held at the Westin La Paloma.
